MIXED TEAM TOURNAMENT RULES

1. Bowlers must have a current USBC card issued through this association, or have purchased an "ASSOCIATION ONLY" membership through this association by September 10, 2019.
2. All bowlers average will be determined in the following manner: Bowlers will use their highest verifiable average on the USBC website (bowl.com) for the 2018-2019 winter, summer or composite average with minimum 21 games or more. Bowlers who do not have an average through USBC for the 2018-2019 season will use their highest current league average of 21 games or more as of October 13, 2019. A standing sheet for the week of 10/19/2019 MUST be presented at check-in. Those not meeting this requirement must bowl scratch. HANDICAP will be 85% from 840 team average.
3. VIOLATION OF ANY OF THE FOLLOWING RULES COULD BE CAUSE FOR DISQUALIFICATION AND THE LOSS OF PRIZE MONEY FOR TEAM:
 - (a) USBC Rule #13 will be in effect for unmarried, grade and high school students.
 - (b) The 10-pin Rule will be in effect. USBC Rule 319/a/2. Each bowler will be responsible for the accurate entering of his/her average, regardless of who may have submitted same. If a lower average is used, bowler will be disqualified.
 - (c) USBC Rule 319c. Bowler must report any previous tournament average adjustment/re-rate.
 - (d) USBC Rule 319d. Reporting prior prize winnings. Bowler who has qualified for a cash and/or merchandise prize within the last 12 months in the categories listed must report those amounts to the tournament manager prior to participation for possible average adjustment.
 - (1) \$300 or more in any event.
 - (2) Total combined prize winnings of \$500 or more in any one tournament.
 - (3) Total combined prize winnings of \$1000 or more in all tournaments within the last 12 months.
 - (e) Any bowling ball that has two with holes is not allowed. If a ball is drilled for a thumb hole and also has a balance weight hole, that ball is not allowed if the bowler does not use the thumb hole for gripping, thus creating two weight holes.
4. SUBSTITUTIONS will be allowed, however, no change in the line-up position of the person being replaced will be allowed. All substitutions will be made at the discretion of the tournament manager and should be made at least 30 minutes before squad times.
5. Tournament Manager may check any bowling ball for USBC specification at any time during the tournament.
6. One (1) Cash prize for each six (6) entries. Per Rule 308, all prize fees collected in an event will be returned 100% to the participants in that event. Entry Fee \$100 per team: Linage \$36, Expenses \$4, Hall of Fame donation \$10, Prize Fund \$50.
7. Late Arrivals - Any bowler arriving after the start of their scheduled squad must start in the frame being bowled when they arrive and will receive ZERO for frames missed.
8. Entry fee will be paid by CASH, CHECK or MONEY ORDER (Payable to OKC USBC Assn.) Entries close 10/7/2019 Midnight. Late entries will be accepted with \$20 Administration fee per Team.
9. Team shall consist of Two (2) male and Two (2) female members. Teams may bowl more than once by changing Two (2) members on that team.
